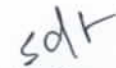

3. Accepting authority does not bind himself to accept the lowest quotation & reserves the right to reject any or all the quotations received without assigning any reason whatsoever and also reserve the right to split up the work along different agencies, if necessary.
4. The quotationer should quote rates on both in words and in figure.
5. The work must be completed within the stipulated time as per work order.
6. The rate should be for complete item of work including supplying, and carriage of all descriptions except otherwise stated and included all charges viz. GST / Sale Tax, royalty surcharge for tools and plant etc. & any other incidental charges. The whole works shall have to be executed as per departmental order available from time to time during execution of the work and no claim what-so-ever for loss of labour materials and/or idle establishment etc. shall be admissible on this account. The rate accepted in the tender shall remain open for acceptance for a period of one year.
